> D'Mone Walker, School Committee Student Representative from Doherty Memorial High School, stated that the Policy Book lists the last day of school for seniors as May 20, 2016 and the updated websites lists May 23, 2016 as the last day of school.

Dr. Boone indicated that the system went through the State's Coordinated Program Review and it was determined that the system was short days on the required minimum of days for seniors so the adjustment that the School Committee approved to the calendar last month was to make that state required shift.
