Purpose/Priorities	Implementing the Flexible Framework, an evidence-based model, is designed to help school districts develop a plan for integrating trauma-sensitive routines and individual supports into the school day. Health Care and Health Promotion Synergy Initiative

The Center for Disease Control and Prevention (CDC) defines an Adverse Childhood Experience as abuse, neglect, or household dysfunction¹. According to the past president of the American Academy of Pediatrics, "Children's exposure to Adverse Childhood Experiences (ACES) is the greatest unaddressed public health threat of our time."²

The Worcester Public Schools (WPS) proposes Worcester's Healthy Environments and Resilience in Schools initiative, or *WorcesterHEARS* in response to this serious threat to health. *WorcesterHEARS* will implement the Flexible Framework³, an evidence based model developed by Massachusetts Advocates for Children, in collaboration with Harvard Law School and the Task Force for Children Affected by Domestic Violence. The Flexible Framework is an action plan that provides guidelines for establishing school wide practices and supports for staff and students. Our researched-based proposal is built on findings from the Kaiser Permanente Foundation and the Center for Disease Control and Prevention in the Adverse Childhood Experiences Study (ACES) and in response to our district's data.

Together, WPS and key partners seek support to develop a comprehensive program in five targeted schools in the Worcester Public School District during our planning stage. We will focus on elementary and middle schools, targeting schools that feed into one another, in order to follow students through the foundational developmental years with a consistent trauma informed approach.

The Flexible Framework

The Flexible Framework is designed to help school districts develop a plan for integrating trauma-sensitive routines and individual supports into the school day. Our initiative, will engage both families and community providers in planning for a collaborative, evidence based model and implementation plan to address the impact of toxic stress, or ACES on Worcester's young people. WorcesterHEARS will accomplish this through (1) providing training and ongoing support to teachers, parents and caregivers and community based youth development workers (2) aligning a trauma-informed response across the three principal environments of school, home, and community.

Initial implementation will involve training throughout the layers of the school, family and community. Our training plan targets:

- All personnel (teachers, support staff, administrators) will participate in the two hour program
 offered by Joel Ristuccia and MassAdvocates, Helping Traumatized Children Learn. This
 will provide all adults interacting with children at the target schools background and resource
 material on the subject.
- A teacher core at each school of 25 percent (with a minimum of three per school) will receive
 extensive training in the Flexible Framework using the Lesley University curriculum and a

- "Training of Trainers" model to assure depth and breadth of expertise in school as well as sustainability.
- Parents, Caregivers and Youth Development Workers will participate in a modified version of the program offered by Joel Ristuccia and MassAdvocates.

Ultimately, our goal is that all caregivers, educators and youth development workers in the identified schools and neighborhoods confidently engage in evidence based and trauma informed practices and pedagogical approaches; providing students with the foundation for educational achievement, lifetime resiliency and health. Using funding from the grant opportunity, Worcester Public Schools will be able to successfully implement the Massachusetts Advocates for Children Flexible Frameworks, a sustainable action plan to support students who are negatively affected by Adverse Childhood Experiences (ACE's) and will result in stronger community partnerships between WPS and community partners, and a new model for improving school climate throughout the district. In response to the challenge of ACE in education, WPS proposes WorcesterHEARS; a comprehensive evidence-based approach to help all students be present and accounted for in school and focused on the task of learning. WorcesterHEARS will: change school climates and policies on discipline and suspension; build resilience in teachers, children and families and community based youth programs; encourage trauma informed school policies and procedures; and ultimately result in more students attending school more consistently and with greater capacity to learn.
