Worcester Public Schools Receives Meritorious Budget Award!

It is with great pleasure and pride that I inform you that the Association of School Business Officials International (ASBO) has awarded the **Worcester Public Schools** its Meritorious Budget Award (MBA) for excellence in budget presentation. The award is conferred only to school districts that have met or exceeded the Meritorious Budget Award criteria.

To earn this award, the school district submitted its 2013-2014 budget for a rigorous review based on stringent criteria.

Developed by ASBO for school districts, the MBA criteria guide school business officials toward a quality school budget presentation by enhancing the school business officials' skills in developing, analyzing, and presenting a school system budget.

It is my understanding that the Worcester Public Schools is only one of four first time recipients nationwide of the award this year. I also understand that the Worcester Public Schools is only the seventh Massachusetts school district in the history of the MBA to have been recognized for this achievement.

The reviewers of the budget document stated:

The budget is a fine document, which includes a wealth of information in graphic and narrative form. The document is user-friendly for the average taxpayer with lots of data presented in different forms to meet the needs of varied users. Many components are suitable, stand-alone documents.
