FY20 PRELIMINARY BUDGET ESTIMATES

Mr. Allen provided an excellent PowerPoint on the analysis of the Governor's Proposed Budget and recent legislative budget proposals as contained in Annex A of the backup.

Mr. Monfredo made the following motion:

Request that the Administration identify an element in each plan that would most benefit the Worcester Public Schools concentrating on the areas of Health, Special Education, English Language Learners and low income students and forward that information to the State Delegation for consideration in the development of a final plan.

Miss Biancheria requested that the Administration provide the enrollment figures at all levels in September 2019, especially since new buildings would have to accommodate these changes.

In response to Miss Biancheria's request relative to allocation meetings, Superintendent Binienda stated that a sheet for request of new items will be filled out by principals for the first time in a long period of time.

Miss Biancheria requested that the School Committee be apprised of the development of the tiered approach to Chapter 74 offerings.

Mr. Allen stated each of the 3 bills is doing exactly what the Foundation Budget Review Commission recommends.

Mr. Foley stated that he is in favor of a 5 year review and update of the Foundation Budget.

Mr. O'Connell stressed the need to meet with the legislators to educate the members as to the areas in each of these bills that will have the greatest impact on the Worcester Public Schools.

Mr. O'Connell stated that it would be the first time that the authority the School Committee has over the allocation funds would be trumped by what the Governor's budget would permit under that particular formula.
