Worcester Public Schools (WPS) no fa saa resots wei anibere paa na yerefa akwan ahorow so asiesie nea aba no. Yene MassDEP nyinaa reye adwuma abom.

Nea eka anammontuo a ewo wo sukuu mu ho no, WPS reye dwumadie ahorow yi wo mantam no nyinaa mu:

1. Wo ahyensodee bi te se "*Nsa Hohoro Nkoaa Ahyensodee*" asi doroben ahorow a lead dade ne/kobere gyinapen no boro lead gyinapen no so ne/anaa kobere Anammontu Gyinapen no so na wonnom nsuo no anaa wammfa noa aduane. Doroben dodow no ara a eboro anammontu gyinapen no so wo mantam no mu ye kyensee a yede hohoro nsa. Massachusetts Asoe a Ehwɛ Akwahosan so no ka se nsuo a lead dade ne kobere wom no nye hu bere a wode hohoro wo nsa.

3. Yene WPS asoe te se Aduanedi, Nɛsin, ne nea etete saa na yede aye anammontu nhyehyee, se eho behia a.
4. Yehwe se yewo nsuo dodow a yenom ne nea yede ye aduane se ese se yeyi doroben bi kakra na yeye nhwehwemu a anaa yede yiye to n'akwan mu. Yadum nea ema nsuo ye nwunu nyinaa, doroben a yenom mu nsuo, ne tua ahorow nyinaa ansaa na yeba sukuu mu besua ade bio wo Obenim 2021. Tua mu nsuo wo ho ma asukuufo nyinaa ne adwumayefo nyinaa saa bere yi.

Wo Massachusetts no, nsuo a yenom dodow no ara a efi nsukurabea ne asaase ase nsuo nni lead dade ne kobere wom. Lead dade tumi ko nsuo mu bere a nneema a wode twe nsuo no ho aka na ewo lead dade wom, te se lead doroben (doroben biara a ewo lead wom no yayi afi ho) a efi dan bi mu ko nsuo mu wo abonten so, anaa nea efi nneema a yede twe nsuo wo dan bi mu. Kobere tumi ko nsuo mu bere a nneema a wode twe nsuo no ho aka na ewo kobere wom.
